CONSUMER PRICE INDEX June 2013

Consumer Price Index (CPI), in June 2013, resulted 114.8 percent against December 2007 (December 07=100), signing a decrease of 0.6 percent against the previous month.

The annual rate in June is 2.3 percent. A year before the annual rate was 2.2 percent.

Compare with previous month:

The index of "Food and non-alcoholic beverage" signed a decrease by 1.4 percent. The highest decrease by 10.4 percent it was notice in the "vegetables include potatoes" subgroups. Here can be mentioned the decrease prices of pepper by 41.2 percent, cucumber by 31.9 percent, eggplant by 30.5 percent, tomatoes by 16.6, green salad by 18.3 percent, etc. The price of "fruit" subgroup signed an increase by 3.5 percent, where can be mentioned increase prices of lemons by 19.5 percent, oranges by 16.0 kiwi by 15.2 percent, etc. Prices are decrease and in some other subgroup of this group, where can be mentioned decreases in the subgroups "milk, cheese and eggs" by 0.6 percent "oil and feat" by 0.4 percent, "sugar and dessert" by 0.3 percent, "non-alcoholic drink" by 0.1 percent, etc.

Index of "Alcoholic drinks and tobacco" signed a decrease by 0.2 percent, within this group price of alcoholic drinks signed an increase by 0.1 percent and price of tobacco a decrease by 0.4 percent.

The index of "Clothing and footwear" group, signed a decrease by 1.2 percent.

The index of "Rent, water and fuel power", signed an increase by 0.4 percent, where can be mentioned the increase price of rent by 0.6 percent and decrease prices of fuel by 0.4 percent.

The index of "Transport" group signed a decrease by 0.3 percent. Within this group prices of diesel signed a decrease by 0.7 percent and prices of petrol a decrease by 0.4 percent.

The index of "Goods and different service" group signed a decrease by 0.4 percent, which is mainly results of decrease of car insurance.

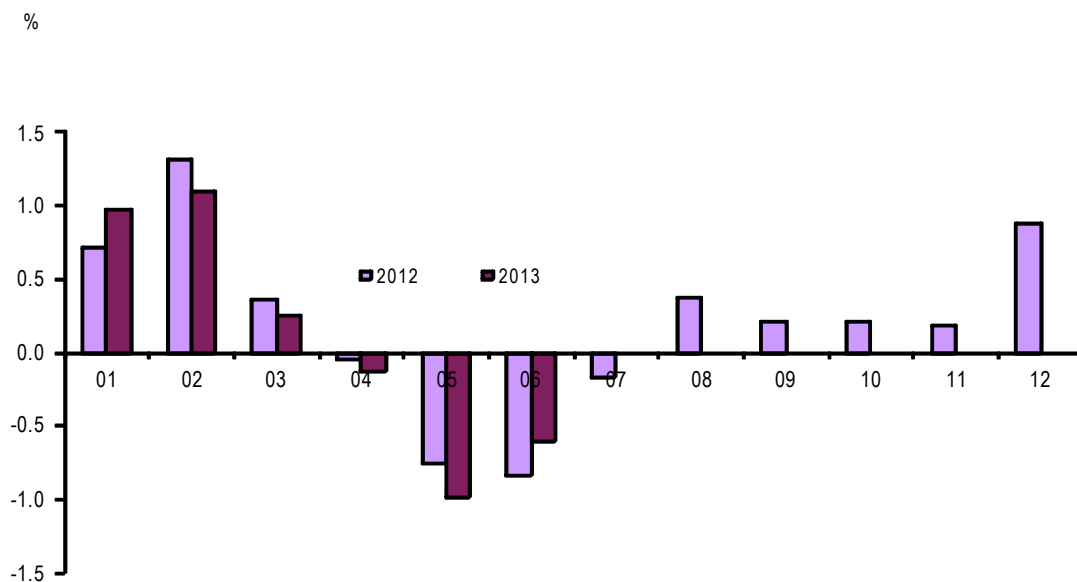
In the other groups changes various from -0.1 to 0.4 percent.

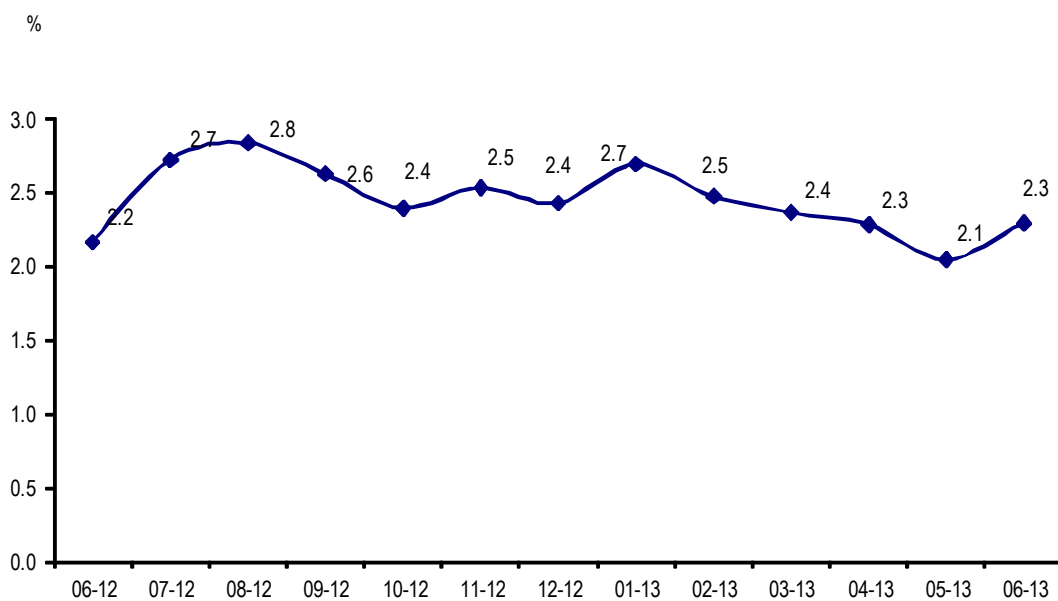

METHODOLOGICAL EXPLANATION

Consumer Price Index (CPI) is calculated with a new basket of product from January 2008. Weights are based on the results of the Household budget Survey, carried out during October 2006 – September 2007.

December 2007 is considered as the base period (December 2007 = 100)

Previous change of the product basket was from January 2002, where the number of the products was increased from 221 to 262 products.

In the new basket the number of product is 272.

The international classification, COICOP, with 12 main groups was introduced to the previous product basket and it will continue to be used with the new product basket.

The index will cover all Albanian (rural and urban) territory. The previous index covered only the urban area.

The product weights will be different for each region.

Prices are collected in main cities of 11 prefectures were Kukes is within the prefecture of Diber.

The Consumer Price Index of Albania is a Laspeyres type index:

$$I_{0,i}^t = \frac{\sum_i P_i^t * Q_i^0}{\sum_i P_i^0 * Q_i^0}$$

With weights ($w = P * Q$) from base period this is approximated to:

$$I_{0,i}^t = \sum_i w_i * \left(\frac{P_i^t}{P_i^0} \right)$$

In more detail, a price relative is calculated for each item and region with geometrical mean on the sample of outlets:

$$PR_{t-1,ij}^t = \prod_{k=1}^n \left(\frac{P_{ijk}^t}{P_{ijk}^{t-1}} \right)^{1/n}$$

Monthly chaining gives the price relative from the base period:

$$PR_{0,ij}^t = PR_{0,ij}^1 * \dots * PR_{t-1,ij}^t$$

The price relatives are aggregated geographically to form product indices on items for whole Albania:

$$I_{0,i}^t = \sum_j r_{ij} * PR_{0,ij}^t \quad \text{where} \quad \sum_j r_{ij} = 1 \quad : \quad \forall_i \quad (\text{for all cases})$$

Aggregation over items then gives the CPI of Albania:

$$CPI_0^t = \sum_i w_i * I_{0,i}^t \quad \text{where} \quad \sum_i w_i = 1$$

The annual rate measures the price change between the current month and the same month of the previous year. This measure is responsive to recent changes in price levels but can be influenced by one-off effect in either month

The monthly rate measures the price change between current month and previous month. Although up-to-date it can be affected by seasonal and other effects.

The 12-month average rate compares average Consumer Price Indices ant the latest 12 month to the average of the previous 12 months.
