

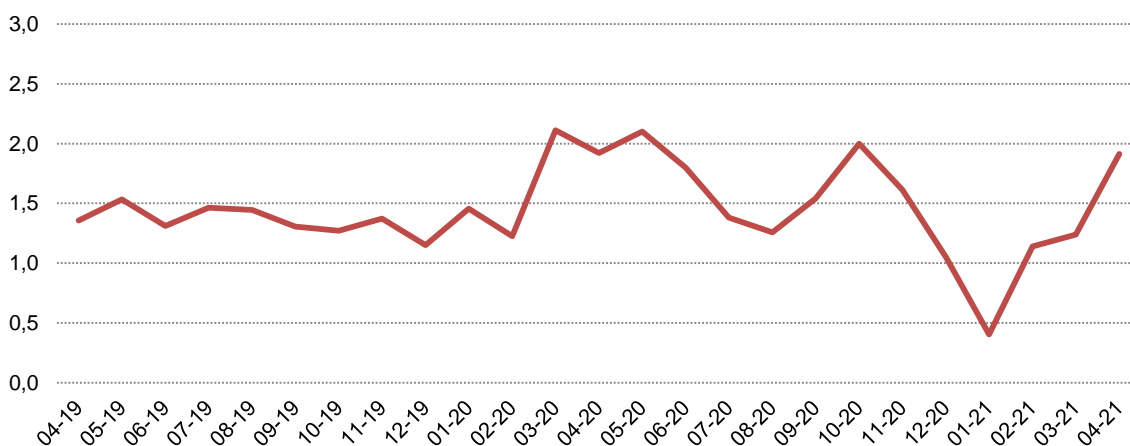
Consumer Price Index

April, 2021

Tirana, on May 10, 2021: Consumer Price Index in April 2021 arrived 103.3 against December 2020 as reference period.

The annual rate of consumer price index in April 2021 is 1.9 %, same as a year before. Compared with March 2021, the monthly change of consumer price index in April 2021 is 0.2 %.

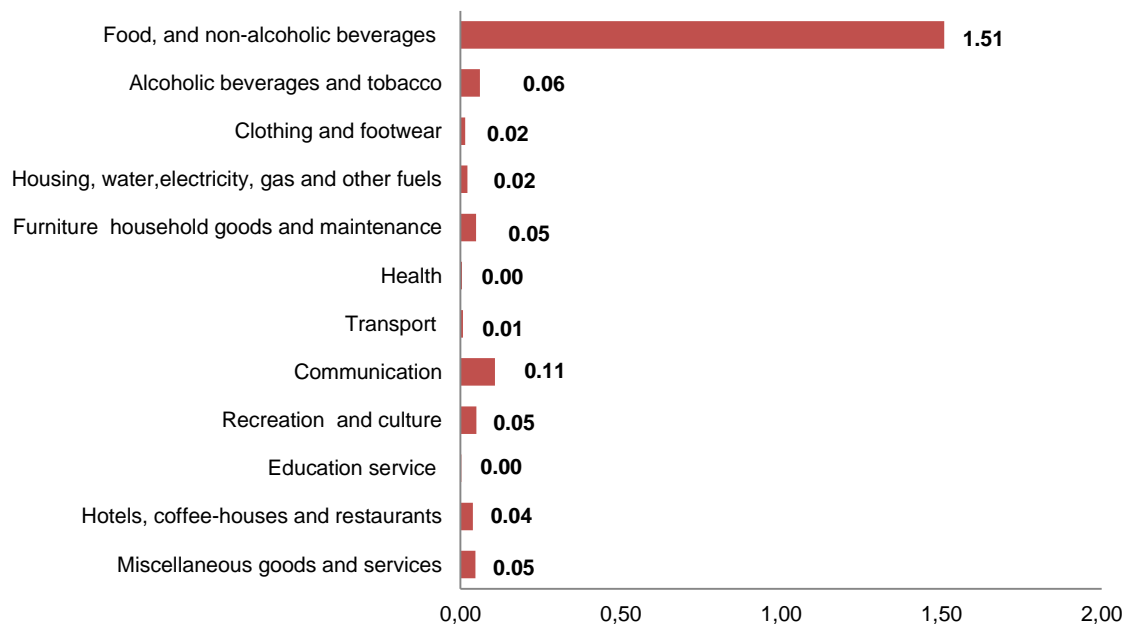
Fig. 1 Annual rate of consumer price index



Contribution of main groups in yearly changes of CPI: Annual growth rate in April was influenced mostly from prices of group “Food and non-alcoholic beverage” by +1.51 p.p., followed by “Communication” group contributed by +0.11 p.p.. Price of “Prices of “Alcoholic beverages and tobacco” group contributed by +0.06 p.p.. Prices of “Furniture household goods and maintenance”, Recreation and culture” and “Miscellaneous goods and services” groups contributed by +0.05 p.p. each of them. Prices of “Hotels, coffee-house and restaurants” group contributed by +0.04 p.p.. Prices of “Clothing and footwear” and “Housing, water, electricity and other fuel” groups contributed by +0.02 p.p. each of them. Prices of “Transport” group contributed by +0.01 p.p..

Yearly rates of main groups: Compared to April 2020, prices increased the most in the group “Food and non-alcoholic beverage” by 4.5 % followed by “Communication” by 3.6 %, “Alcoholic beverages and tobacco” by 1.7 %, “Recreation and culture” by 1.3 %, “Hotels, coffee-house and restaurants” by 1.0 %, “Miscellaneous goods and services” by 0.8 %, “Furniture household goods and maintenance” 0.6 %, “Clothing and footwear” by 0.4 %, “Transport” by 0.3 %, “Housing, water, electricity and other fuel”, “Health” and “Education service” by 0.1 % each of them.

Within the food group prices of “vegetables included potatoes” subgroup signed an increased by 10.2 %, followed by “oil and fats” by 4.6 %, “fruits” by 4.4 %, “fish” by 2.5 %, “milk, cheese and eggs” by 1.9 %, “bread and cereals” by 1.8 %, “meat” by 1.2 %, etc.

Monthly rates of main groups: Compared with March 2021 prices of “Recreation and culture” increased by 2.1 %, followed by “Communication” by 1.3 %, “Food and non-alcoholic beverage” by 0.4 %, “Clothing and footwear” and “Miscellaneous goods and services” by 0.2 % each of them, “Alcoholic beverages and tobacco”, “Transport” and “Education service” by 0.1 % each of them. On the other hand prices of “Health” decreased by 0.6 %, followed by “Furniture household goods and maintenance” by 0.5 %.

METHODOLOGY

- Methodological changes

In January of each year some methodological changes and new developments were carried out in CPI:

- Update of weights: Weights are changed; they are now based on the average expenditure from 2018 Household Budget Survey.
- Update of basket: The list of goods and service content 331 products.
- Update of list of the outlets where the prices are collected is updated.

Started from January 2021, the consumer price index is calculated with the new base period. December 2020 is considered as the base period (December 2020 = 100).

INSTAT during the Pandemic period has been following the latest recommendation coming from EUROSTAT and other international partners.

- Definitions

The annual rate measures the price change between the current month and the same month of the previous year. This measure is responsive to recent changes in price levels but can be influenced by one-off effect in either month

The monthly rate measures the price change between current month and previous month. Although up-to-date it can be affected by seasonal and other effects.

The 12-month average rate compares average Consumer Price Indices ant the latest 12 month to the average of the previous 12 months.
